#### 第 53(3)條 / Section 53(3)

If the Purchaser after signing of preliminary agreement for sale and purchase finally elects not to apply for the "Interest only for the first 3 years of the 70% First Mortgage Loan" mentioned in paragraph (4)(iii)(a) above, the Purchaser shall be entitled to a cash rebate provided by the Vendor which is equivalent to 3% of the Transaction Price, provided that the Purchaser shall give a written notice to the Vendor not less than 30 days before the date of the payment of the balance of the Transaction Price confirming that the Purchaser will not apply for the "Interest only for the first 3 years of the 70% First Mortgage Loan".
